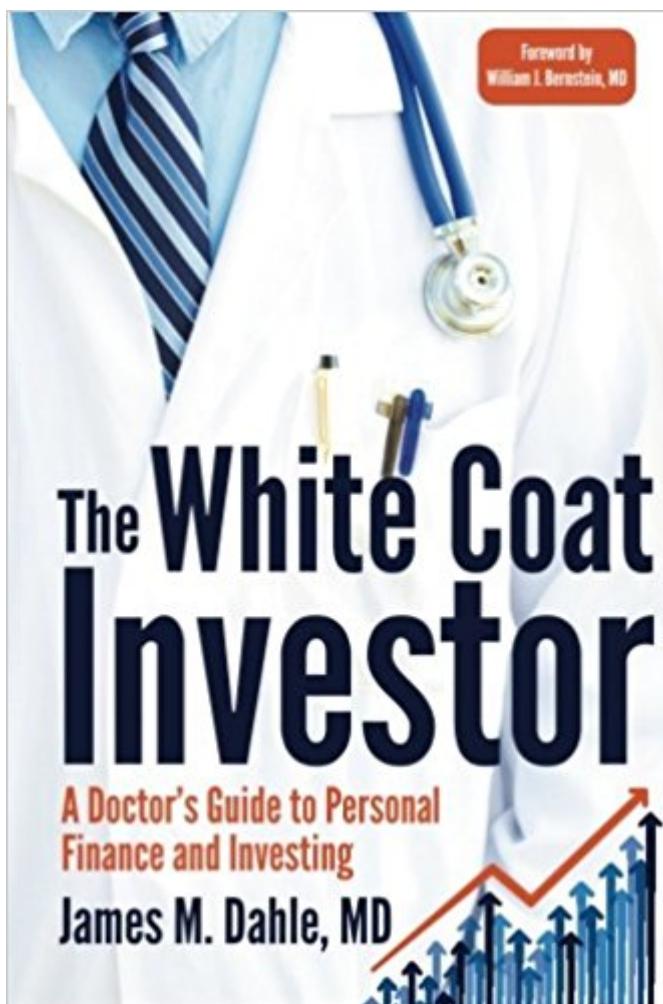

Now he shares his wisdom with medical students, residents, physicians, dentists and similar high income professionals so they can free themselves from debt, quit worrying about money, build wealth, live "the good life," and get back to practicing medicine on their own terms. The principles he espouses are neither complicated nor risky, but the process of becoming wealthy as a physician is by no means automatic.

The book is an excellent guideline to physicians at any stage of their career if/when they become interested in personal finance, investing, and becoming financially independent/secure. It's an excellent resource to start with and has several links to more resources should the reader be interested. The book, admittedly so, doesn't try to be an exhaustive or an in depth technical reference to everything you'll ever need to know about personal finance or investing, but it does provide a good foundation upon which to

conceptualize your own approach to these topics and has unique insight into how these topics may affect those of us in the medical profession. If you are a physician or other high income earner starting down the road to personal finance and investing, I would recommend this book if for nothing else than the authors perspective on the financial reality of physicians despite our perceived high income and how financial decisions early in our training will affect us long after we eventually become attendings. However, the book offers much more than this, is an easy read, and points you in the direction of trusted information when you're ready to expand beyond the limits of this book.

I, like many of you, found my way to this book more than once through various blog posts and after reading it I strongly recommend picking up a copy. Even paying the full price of this book (which is unlikely being you're already on looking at it) is completely worth it if you find and follow just one of the ideas in this book because they can literally save you thousands of dollars year after year!

Unfortunately, physicians and high-income professionals can be susceptible to unscrupulous sales tactics due to a lack of financial education and money management. Jim shares his trials and tribulations as he navigates the murky waters of his financial experiences in an honest and entertaining way. His mission "to help physicians get a 'fair shake' on Wall Street" is one of pure sincerity to inform the uninformed. I found the chapters on asset protection, estate planning, income taxes, and business structures extremely helpful. Overall, an excellent resource to add to your library!
