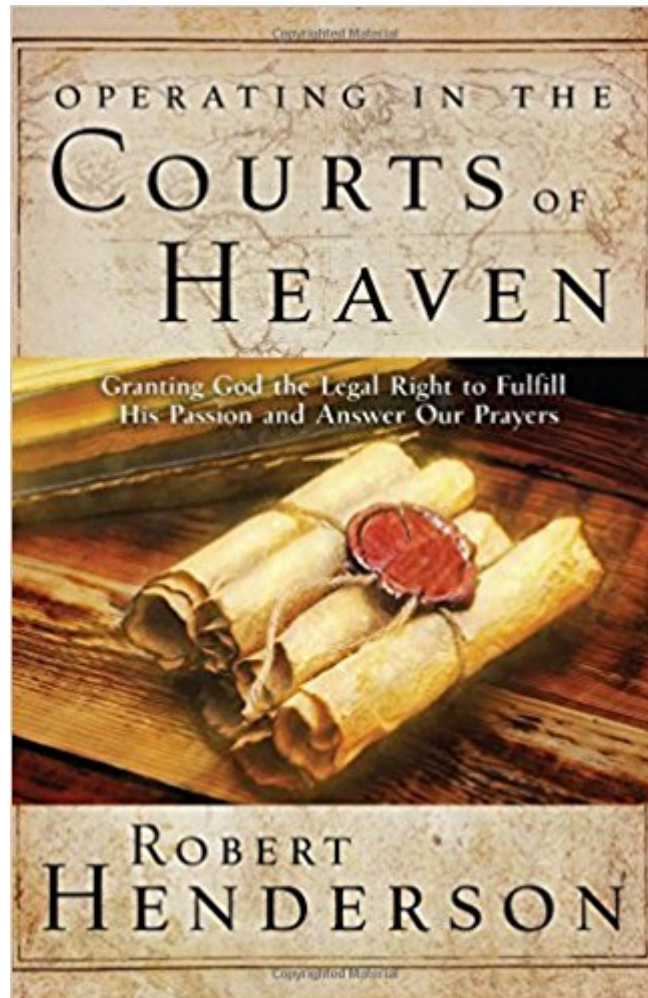

This book is amazing and answers the question, "Why are my prayers not being answered?" So few understand that God's Kingdom is a kingdom with laws as well as privileges. Many of these accusations are un-refuted because we don't even show up for a defense! If you don't show up for court you lose! This book shows us God's legal system and how to defend yourself against Satan's accusations. Once we understand this fundamental principle the heavens can begin to LEGALLY move on our behalf! This is a MUST read for EVERY serious believer!

This book is like a diamond in a lump of coal--both in the same book. I love and hate this book (love the core insights and hate how badly it's written). Sorry, I'm a writer, and a Bible college teacher, so I pick up on these things. The insights and overall basic teachings are phenomenal and of utmost importance. I'm so glad to be introduced to what Henderson is saying. These excellent insights need to be taught to all Christians--but probably through other material. That said, Henderson needs to better study and know the true Greek meaning and usage of terms. He also needs to work on and refine his use of theological language--along with improving poor grammar, usage, style, and punctuation. He's got questionable theology in places, for example, lots of eisegesis (imputing one's own view or assumption to a word--rather than exegesis, which is objectively examining and drawing the meaning out of a word). He also does lots of interpreting Scripture as if legality explains everything in prayer or spiritual warfare, and there is nothing else. He says that "God can only do what we allow him to do," and that "we give God the right to..." Even the subtitle reads: "Granting God the Legal Right to Fulfill His Passion and Answer our Prayers." Really? As if WE are in the position to grant or allow God rights. That alone contradicts the whole courtroom motif that concerns the entire book. And such presumption trivializes God's omnipotence to say the least. So if you can dig out the diamonds in this lump of coal, get the book. Otherwise other teaching material

may be a better choice. My respectful apologies for all this, but on a subject this important, I am compelled to be honest.

I believe the book has merit. There are courts and kingdom adjudication that further God's purposes when done right. The preexistence discussion, evolution of books and some poor word studies actually weaken the cause of the main theme. Overall there is more good.

The first half of the book was really good, but at the halfway point, it became too subjective for me. There wasn't many scriptures to back up the subjective experiences. I still think at least the first half is well worth the read.

The truths I'm learning in this book and the second one, too, are the most important things I've learned in years. The Bible study and prayer group I lead are now reading and discussing this book together and the other ladies are as excited as I am about the things we are learning.

This book turned my head and helped me see things I'd never seen before. I am so grateful for being turned on to this book. Since reading it, I've caught Robert Henderson on YouTube as well. Learning how to go to the Throne of Grace and get our needs met was a big take-away as well as learning about how our finances affect our testimony - life changing for me.
