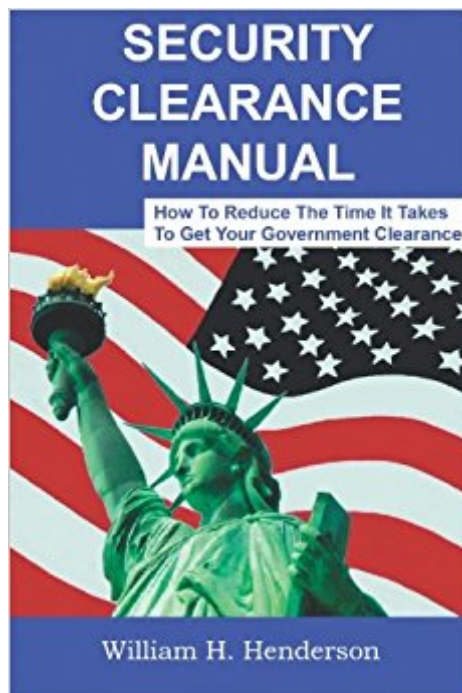

If you aren't concerned about how to fill out one of these forms, you haven't been paying attention. Jobs are tough to come by these days. Screw up a government security clearance and a placement firm might have second thoughts about placing you in a non-government job. The older you are, the more likely you have run into things that might not look so great. The younger you are, the more likely you may have a youthful indiscretion or you aren't experienced enough to understand this is way different than filling out a job application. I mentioned we were doing this task to more than one person. Each said, "Oh, you don't have to worry about anything, you need to understand that employers can't ask about 'blah blah blah.'" I would shoot back... "This isn't about an employment application... think HOMELAND SECURITY." If these answers set off flags to investigators, they have the right to go out to your neighborhood, show a federal badge and ask your neighbors questions! It may be unlikely, but the government has the right. This book clarified how much detail to use so you don't write too much or too little. The REALLY BIG HELP was that this book was also available on line. We paid for it and started reading right away. We were on a deadline to get this form turned in and we could not have waited for it to be mailed to us. We did also have a hard copy mailed to us. This was so valuable, we will keep the hard copy in case ever decides not to have it online and we could not access it online.

This book could use a lot more editing, particularly in the format. I found the book hard to use and hard to understand. It was difficult to penetrate the government legalese. I understand that this topic is difficult, but the author's job is to explain these difficult issues in terms that anyone can understand. Unfortunately, this author appears to just be another policy wonk speaking wonkish. A good editor could have helped make this a lot better. Large portions of the text appeared to just be text that the author had copied and pasted from Federal Websites. That said, if you are getting a Security Clearance, there is some decent information contained in this text, so it might be your only choice, even if it is hard to understand.

I read this book cover to cover. I didn't know a lot of details about the process of going through a government clearance before reading this book. I decided to get this book and it has helped me clarify some important points. In fact, my investigator called me and commended me my application and how easy it has been for her. This book does not guarantee clearance but I believe it does increase your chances. Most importantly be honest when answering questions because it will make

things that much easier.

This book was recommended by a friend who does the security checks for a living. This book tells you what's going on and why. It's not a manual on how to pass but rather what they are doing and why. It takes some of the mystery away but lets you know about the process.
