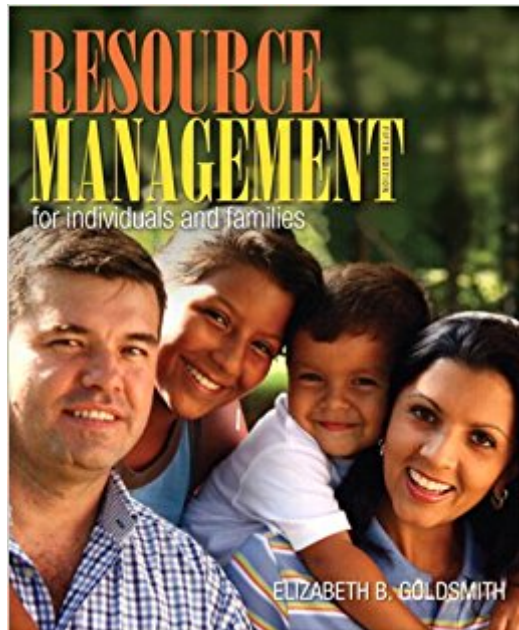

I think the information was very valuable, but sometimes it's a little bit difficult to navigate and find certain key points that you want to reference.

It was probably more the professor teaching the class this book was for, who was TERRIBLE, but the book itself is like reading a how-to on grocery shopping; thoroughly researched and well organized, but ultimately it's a super verbose explanation of really common knowledge, and one or two concepts that would only require maybe two pages of explanation, rather than 5 chapters.

I ordered this book for a college class and it is a great read. Most of the chapters repeat the same material but there is also great info within this book like the chapters on motivation and time management. Easy read.

I bought this book for a graduate course. It was a good book for the course. A great read for a learning foundation in family and individual recourses and management. However, the past three chapters were all mixed up, which made it difficult to read I plan to call them about it. It was shipped by STANZA. I probably won't buy from them again.

This book came pretty beaten up. The binding is really weak. Every time I open it I am afraid the whole thing is going to fall apart. There are ripped and folded pages as well. Overall, I am less than impressed.

My textbook was shipped fast but I'm just noticing it is missing whole sections. It skips from chapter 12 into chapter 13 with pages missing in chapter 14. I didn't take notice as I wasn't in those chapters until now halfway through the semester. It doesn't appear anyone ripped them out but it seems like they were just never printed and out into the binding as the binding is still fully intact.

I purchased this book for my Resource Management course and it was very clear and to the point.
