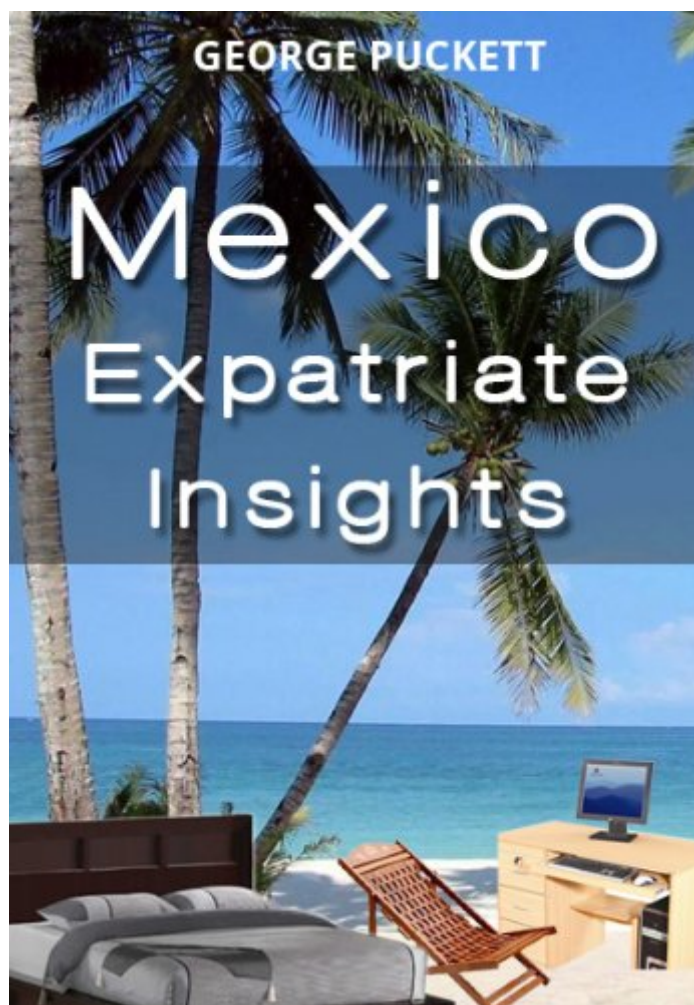

We attempt to address some of these concerns in Part 2 of the book, which we refer to as, "The Expatriates Essential Knowledge Base." Many Expatriates are also interested in taxes. What are their tax liabilities? Will they have to pay income tax on their US income? If they earn money in Mexico, will the US tax them on that income? Included is an interesting article by Don Nelson, an Expatriate/Attorney/CPA. Don answers many of these questions.
